Tournament Rules

1. Bowlers must be a member of USBC. If not, purchase of an unattached membership (cost \$20) will be required prior to bowling in tournament.
2. The tournament will consist of non-tandem Doubles and Singles events, and an optional All Events, in three divisions: Men, Women and Mixed.
3. Lanes will be stripped and oiled before every squad.
4. Multiple entries will be allowed. To place more than once in the prize list for position standings:
 - a. Doubles – At least one player in the lineup must be different.
 - b. Singles – The same individual cannot place more than once.
 - c. All Events – The bowler's first appearance in each event counts towards their all-events total.
5. Entering Averages: All bowlers will use their highest league average (minimum 21 games) from the previous season. If a bowler has no average from the previous season, then use the bowler's highest current certified league average posted as of the start of the tournament (minimum 21 games; a copy of the league standing sheet signed by the league secretary must be supplied for verification). All bowlers not meeting these requirements may enter with a "scratch" average of 220 in the Men's and Mixed divisions or 180 in the Women's division.
6. The "ten-pin average increase" rule (USBC rule 319.a.2.) will be waived.
7. All bowlers must be familiar with USBC Rule 319.c. concerning average adjustment. Any entrant who has qualified for a prize of \$300.00 or more in any event of any tournament within the past 12 months, must report the actual scores, name of tournament, position, and the amount won per USBC Rule 319.d. USBC Rule 319.e will be waived.
8. All bowlers must be aware of USBC Rule 319.a. which states in part: "failure to use the proper average shall disqualify the score(s) if the submitted average is lower than the actual average, thereby resulting in a lower classification or handicap." No averages will be adjusted downward once the tournament has started.
9. Handicap: 100% of the difference between each individual bowler's average and 220.
10. All prize fees will be returned 100%. No entry fees will be returned once this tournament has started, unless granted by the tournament committee.
11. All bowlers must check in at least 30 minutes prior to their squad time.
12. Team captains are responsible for verifying the entering averages of all team members.
13. Re-entries will be permitted on each squad whenever openings exist.
14. In case of disputes, rules interpretations, etc., immediately notify the tournament manager or other tournament officials.
15. This tournament is certified by the USBC. USBC Tournament Rules will govern any rules not listed or specifically waived on the tournament entry form.
16. Make sure that your entry form is complete with all the required information.
17. All entry forms must be submitted with a check or money order for all fees.
18. Use of cell phones is prohibited in the bowling area.
